

Amendment & Clause added mission statement to specific and primary purpose for which the organization was form: To provide various support Programs, Outreach to Community at large as follows:

- A. Pre-school Day Care
- B. Youth Care & Activities
- C. Remedial, Literary training
- D. Meals
- E. Food Bank
- F. Computer and Typing Skill Training
- G. Elderly Day Care & Activities

To also provide Shelter & Transitional Housing to the Low Income and Youth Individuals in need of such provisions.

#### Article VII

No part of the net earnings of the organization shall inure to the benefit of any member, trustee, director, officer of the organization or any private individual ( except that reasonable compensation may be paid for services rendered to or for the organization), and no member, trustee share in the distribution of any of the organization's assets on dissolution of the organization.

#### Article VIII

No substantial part of the activities of the organization shall be carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by IRS 501 C 3 or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of or I opposition to any candidates for public office.

#### Article VIV

In the event of dissolution, all of the remaining assets and property of the organization shall after payment of necessary expenses thereof be distributed to such organizations as shall qualify under section 501 C 3 of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent Federal tax laws, or to the Federal government or State or local government for a public purpose, subject to the approval of a Justice of the Supreme Court of the State of Florida.
