ARTICLE I.

Name

The name of this Corporation shall be: Friends of Daytona Beach Community Foundation,  
Inc.

ARTICLE II.

Duration

The duration of this Corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

ARTICLE III.

Purpose

The purpose of the Corporation shall be exclusively charitable in nature, to-wit: To engage exclusively in activities for charitable and educational purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future federal tax code).

#### ARTICLE IV.

##### Principal Office and Registered Agent


