## Articles of Incorporation

The undersigned, acting as Incorporator of a corporation pursuant to Chapter 617, Florida Statutes, (Not for Profit), adopts the following Articles of Incorporation:

Article I: NAME: The name of the corporation in the state of Florida shall be: TRUTH (for public benefit, inc.)

Article II: MAILING ADDRESS: The street address and mailing address of the corporation shall be: 9303 U.S. Hwy. 41 North, Palmetto, FL 34221 - P.O. Box 7313, North Port, FL 34287

Article III: PURPOSE: The corporation is organized exclusively for the charitable purpose of advancement of religious truth for public benefit through the means of radio broadcast and/or other media communication.

Article IV: MANNER OF ELECTION OF DIRECTORS: The manner in which the directors are elected or appointed are as set forth in the bylaws of this corporation.

Article V: LIMITATION OF CORPORATE POWERS: The corporate powers of this corporation as provided in Section 617.0302, F.S., are subject to the following limitations: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to any insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.
