IN COMPLIANCE WITH CHAPTER 617, F.S., (NOT FOR PROFIT)**

**ARTICLE I: NAME**

THE NAME OF THE CORPORATION SHALL BE:

**FAITH DELIVERENCE TABERNACLE MINISTRIES, INC.**

**ARTICLE II: PRINCIPAL OFFICE**

THE PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS OF THIS CORPORATION SHALL BE:

**3238 PRATHER DRIVE, JACKSONVILLE, FL 32216**

**ARTICLE III: PURPOSE**

THE PURPOSE FOR WHICH THIS CORPORATION IS ORGANIZED IS: SAID CORPORATION IS ORGANIZED EXCLUSIVELY FOR RELIGIOUS PURPOSES. THE MAINTENANCE AND SUPPORT OF THE PUBLIC WORSHIP OF ALMIGHTY GOD IN ACCORDANCE WITH THE TEACHINGS OF THE HOLY SCRIPTURES MARK 16:15-20. TO CONSECRATE BISHOPS, ORDAIN ELDERS AND MINISTERS, TO PRAY FOR MISSIONARIES WHO ARE DIVINELY CALLED, AND TO SEND THEM OUT ACCORDING TO THEIR GIFTS AND CALLING, WHO SHALL BE REQUIRED TO TEACH AND PREACH THE GOSPEL SET FORTH IN THE HOLY BIBLE. I TIMOTHY 3:1-15, 5:17-21, II TIMOTHY 4:2, EPHESIANS 4:11-14, ACTS 13:1-5 ORGANIZED FOR THE FELLOWSHIP OF CHRISTIANS, REGARDLESS OF RACE OR NATIONAL ORIGIN, WHO ARE SPREADING THE GOSPEL OF OUR LORD JESUS CHRIST AT HOME AND THROUGHOUT THE WORLD, THROUGH THE SENDING FORTH OF EVANGELISTS AND MISSIONARIES (MATTHEW 28:19-20), WHO ASSEMBLE IN REGULAR MEETINGS FOR WORSHIP AND PRAISE (HEBREWS 10:19-25). THE ACTIVITY IS CURRENTLY IN PROCESS. THE ACTIVITY IS BEING PERFORMED AT OUR CHURCH FACILITIES BY THE PASTOR, DEACONS AND MINISTERS, PURPOSES, INCLUDING, THE RECEIVING AND MAKING DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501C3 OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF OR BE DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES, OFFICERS OR OTHER PRIVATE PERSONS EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF 501C3 PURPOSES. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION AND THE CORPORATIONS SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF

OR IN OPPOSITION TO ANY CANDIDATE FOR PUBLIC OFFICE. NOT WITH STANDING ANY OTHER PROVISIONS OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY AN CORPORATION EXEMPT FORM FEDERAL INCOME TAX UNDER SECTION 501C3 OF THE INTERNAL REVENUE CODE (OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE) OR (B) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170C(2) OF THE INTERNAL REVENUE CODE (OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE).

IN THE EVENT OF DISSOLUTION, ALL OF THE REMAINING ASSETS AND PROPERTY OF THE ORGANIZATION SHALL AFTER PAYMENT OF NECESSARY EXPENSES THEREOF BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501C3 OF THE INTERNAL REVENUE CODE OF 1986, I.E. RELIGIOUS, CHARITABLE, EDUCATIONAL, SCIENTIFIC, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE. HOWEVER, IF THE NAMED RECIPIENT IS NOT THEN IN EXISTENCE OR NO LONGER A QUALIFIED DISTRIBUTES, OR IS UNWILLING OR UNABLE TO ACCEPT THE DISTRIBUTION, THEN THE ASSETS OF THIS CORPORATION SHALL BE DISTRIBUTED TO A FUND, FOUNDATION OR CORPORATION ORGANIZED AND OPERATED EXCLUSIVELY FOR THE PURPOSES SPECIFIED IN SECTION 501C3 OF THE INTERNAL REVENUE CODE (OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE). ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE ORGANIZATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES.

**ARTICLE IV: MANNER OF ELECTION**

THE MANNER IN WHICH DIRECTORS SHALL BE ELECTED OR APOINTED SHALL BE PROVIDED IN THE BY LAWS.




