NON-PROFIT

OF

The undersigned, for the purpose of forming a Non-profit Corporation pursuant to Florida law, Section 617 hereby certifies as follows:

ARTICLE I. NAME

The name of this corporation not for profit shall be
FAITH IN ACTION FOR YOUTH & EDUCATIONAL ADVANCEMENT, INC.

ARTICLE II. PURPOSE

The purposes for which the corporation called Faith in Action For Youth & Educational Advancement, Inc. is organized and exclusively religious, charitable, scientific, literary, educational, and athletic within the meaning of section 501 (a) of the Internal Revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law. State.

ARTICLE III. TERM OF EXISTENCE

This corporation shall exist perpetually.

ARTICLE X. DIRECTOR




