**ARTICLE I. NAME**

The name of this church shall be SOUND OF THE SPIRIT CHRISTIAN FELLOWSHIP CHURCH, INC

**ARTICLE II PRINCIPAL OFFICE**

The principal headquarters and mailing address of this corporation shall be:

**ARTICLE III PURPOSE**

The purpose for which this corporation is organized is:  
A ministry dedicated to serving God and proclaiming the gospel of Jesus Christ.  
Our goal is to serve God as directed by the Holy Spirit and minister to the community according to His will. Our desire is to be a live, Spirit filled, Bible teaching church, recognizing the privilege and duty of uniting ourselves for public Christian worship and the advancement of His church here on earth. We agree to maintain the teaching and preaching of the Word of God.

**ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed:  
All prospective directors shall be appointed by the president, subject to a unanimous confirmation by the existing board of directors, followed by a unanimous confirmation by the congregation of the church. President and all directors shall be sustained annually by a unanimous confirmation of the congregation of the church.

ARTICLE VIII    PROPERTY

Section 1.

All musical equipment, including: Public Address System, (amplifiers, speakers, microphones cords, etc.), piano, organ, electronic keyboards, electronic drummer, guitar, and guitar amplifiers are personal and private property of David L. George and Judy W. George. These items are on loan only, and, in the event of the corporation being dissolved, these items shall be returned to the loaning parties.

Any other equipment purchased by the church and becoming church property shall be approved by the governing board and recorded in the secretarial minutes of the meeting. Upon purchase of such equipment, the serial numbers shall also be recorded.

Section 2.

In the event the corporation name changes, or there is a change of directors or officers, all church property shall transfer with the change.

Section 3.

In the event the corporation is dissolved, all church property shall be disbursed in one of two ways: (a) all property may be liquidated and proceeds from such liquidation be given to another non-profit charitable organization, or, (b) all property may be donated directly to another non-profit charitable organization.
