We, the undersigned, hereby associate ourselves together the purpose of becoming a corporation not for profit under Chapter 617, laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit.

ARTICLE I: NAME

The name of the corporation is **P-3 MINISTRIES INC.**

ARTICLE II: PURPOSE

This not for profit corporation is organized for the purpose of transacting any or all lawful business including Transitional Housing, Counseling, providing living resource information, providing after school study and activity programs, and senior citizen day care.

ARTICLE III: PRINCIPAL OFFICE

The street address of the principal office is 1953 West 9th Street, Jacksonville, Florida 32209.

ARTICLE IV: INITIAL REGISTERED OFFICE AND AGENT

ARTICLE V: DURATION

(d) Indemnification. The board of directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.

ARTICLE VII: BYLAWS

The director shall adopt the initial bylaws of this corporation. Bylaws shall be adopted, altered, amended or repealed from time to time by either the members or the board of directors, but the board of directors shall not alter, amend or repeal any bylaw adopted by the members if the members specifically provide that such bylaws is not subject to amendment or repeal by the directors.
