ARTICLES OF INCORPORATION OF SERA HOUSING CORPORATION, INC. A FLORIDA NOT FOR PROFIT CORPORATION

ARTICLE L NAME

SECRETARY OF SECRE

The name of the Corporation is SERA Housing Corporation, Inc.

ARTICLE IL DURATION

The duration of the Corporation is perpetual unless dissolved according to law. Corporate existence shall begin upon approval by the Secretary of State. The initial business and mailing address is 21310 N.W. 37th Ave. Carol City, FL 33056.

ARTICLE III. PURPOSES

The purposes for which the Corporation is organized are: (i) to hold and collect income from real property as described in Section 501(c)(2) of the Internal Revenue Code of 1986, as amended, or any successor provision thereto ("Section 501(c)(2)"), (ii) to remit the entire amount of such income, less expenses, at least annually to the Universal Foundation for Better Living, Inc. an Illinois not for profit tax exempt religious corporation, and (iii) to engage in the transaction of any or all lawful business in connection therewith for which corporations may be incorporated under the Florida General Corporation Law; provided however, that notwithstanding the above, the purposes of the Corporation shall be limited to the purposes described in Section 501(c)(2).

ARTICLE IV. RESTRICTIONS

The Corporation shall not engage in any action which is not permitted to be carried on by a corporation organized under Section 501(c)(2) of the Internal Revenue Code and no part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors or officers, except however the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

All corporate property shall be irrevocably dedicated to the purposes described in these Articles.

No substantial part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

ARTICLE V. DISSOLUTION

Upon dissolution of the Corporation, all assets shall be distributed to the Universal Foundation to Better Living, Inc. a not for profit, tax exempt 501(c)(3), religious corporation, exclusively for the exempt purposes of that corporation.

ARTICLE VI. DIRECTORS
