ARTICLES OF INCORPORATION THE GOOD NEWS HOUSING & REDEVELOPMENT AGENCY INC.

The undersigned subscriber to these Articles of Incorporation is a natural person competent to contract and hereby form a Not-for-Profit Corporation under Chapter 617 of the Florida Statutes.

ARTICLE ONE: NAME

The name of this corporation is:

THE GOOD NEWS HOUSING & REDEVELOPMENT AGENCY INC. (hereinafter, "Corporation")

ARTICLE TWO: PURPOSE OF CORPORATION

The purpose of this Corporation is to engage in any lawful business, act or activity for which a corporation is permitted to engage in under the Laws of the State of Florida and the United States. Additionally the purpose is extended to specifically include providing affordable housing to low and moderate income prospective homebuyers. The Corporation will also provide for a Christianity-based program to facilitate educational. financial, constructional and rehabilitative informative assistance to prospective homebuyers and other low to moderate income households.

ARTICLE THREE: PRINCIPAL OFFICE

ARTICLE SEVEN: CAPITAL STOCK

This Corporation shall have no capital stock and shall be composed of members rather than shareholders.

ARTICLE NINE: POWERS OF CORPORATION

The Corporation shall have the same powers as an individual to do all things necessary or convenient to carry out its business and affairs subject to any limitations or restrictions imposed by applicable law or these Articles of Incorporation.

ARTICLE TEN- TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE ELEVEN: VOTING RIGHTS

Members of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.

ARTICLE TWELVE: REGISTERED OFFICE AND REGISTERED AGENT

The initial address of the registered office of this Corporation is 1000 U.S. Highway 1, Suite 757, Jupiter, Florida 33477. The name and address of the initial registered agent of this Corporation is Robin Sing-Cunningham 1000 U.S. Highway 1, Suite 757, Jupiter, Florida 33477

ARTICLE THIRTEEN: BYLAWS

The Board of Director(s) of the Corporation shall have power to make, alter, amend or repeal the Bylaws of the Corporation, but the affirmative vote of a number of Directors equal to a majority of the number who would constitute a full Board of Director(s) at the time of such action shall be necessary to take any action for the making, alteration, amendment or repeal of the Bylaws.

ARTICLE FOURTEEN: EFFECTIVE DATE

Every amendment shall be approved by the Board of Directors, proposed by them to the Members, and approved at a members meeting by a majority of the Members, unless all the Directors and all the members sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

ARTICLE SIXTEEN: LIABILITIES FOR DEBTS

Neither the members nor the members of the Board of Directors or the Officers of the Corporation shall be liable for the debts of the Corporation.
