The undersigned acting as incorporator of a corporation pursuant to Chapter 617 of the Florida Statutes, adopts the following articles of incorporation for the corporation:

**ARTICLE I**

Name

The name of the corporation shall be HogTown Recreational Riders, Inc., and the principal address of the corporation at the time of incorporation is 14101 Millhopper Road, Gainesville, FL 32653.

**ARTICLE II**

Duration

The duration of this corporation is perpetual, unless dissolved according to law.

**ARTICLE III**

Purpose

The specific and primary purpose for which this corporation is organized is to provide social and recreational motor sports and other like activities for its members and to operate exclusively for pleasure, recreation and other nonprofit purposes.

**ARTICLE IV**

Qualifications and Admission of Members

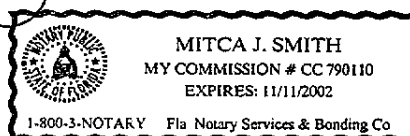

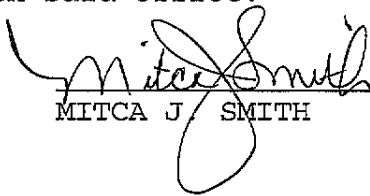
