Article I

The name of the corporation is African Culture Exchange, Inc.

Article II

African Culture Exchange, Inc.

Article III

The purpose of this corporation is as follows

A. This Corporation is a Not-For-Profit Corporation organized under Chapter 17, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of the Corporation is as follows

1. To provide awareness and culture arts of the African people in the United States and an awakening of the Afro American to the music, arts, dance, food & programs. To acquaint the Afro-American with the religion of Africa and traditional rights.
2. To develop a support program that will provide educational opportunities for those from the Western World seeking knowledge and understanding with African Culture, Arts, and Religion.
3. To provide special services for exchange students to American Culture and traditions such as housing, clothes, food and emergency shelter care, and medical programs.
4. To exercise all rights and powers conferred by the laws of the state of Florida upon Non-profit Corporations.

B. Notwithstanding any other provisions of the Articles. The purpose for which the Corporation is organized are exclusively religious, charitable, scientific, literacy, and educational within. The meaning of section 501 C 3 of the Internal Revenue Code of the 1986 or the corresponding provision of any future US Internal Revenue Law.

C. Provide however that the corporation shall not engage in any action which is not permitted to be carried on by Non-profit corporation under the internal revenue code and no part of the net earnings of the corporation shall endure to the benefit of or be distributed to its members, directors, or officers. The corporation shall be authorized and

Article IV

The corporation shall have voting members who shall be elected (and may be removed) by the voting members and who shall have all the rights and privileges of the members of the corporation. The By-laws may provide for Non-voting members of one or more classes, who shall be admitted in such manner and shall have such rights and privileges as are set forth on the By-laws, but who shall not have the right to vote. Directors are elected in accordance with by-laws

Having been named as Registered agent and to accept service of process for the above Stated Corporation at the place designated in this Certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties and I am familiar with the accept the obligation of my position as Registered Agent.
