## STATE OF FLORIDA ARTICLES OF INCORPORATION HISPANICS UNITED INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE 1 The name of the corporation is: HISPANICS UNITED INC.

# ARTICLE III The objectives and purposes for which the corporation is organized are:

- A. To operate as a corporation not-for-profit pursuant to Chapter 617, Florida Statutes.

- J. Notwithstanding any of the above statements of purposes or powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

The business and affairs of the Corporation shall be managed by a Board of Directors which shall initially consist of three (3) directors, but which number may be increased from time to time by the Bylaws of the Corporation but which shall never be less than three (31 The Bylaws shall provide for the method of selecting and the method of determining the number of directors.
