The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**            **The name of the corporation is: HISPANICS UNITED INC.**

**ARTICLE II**           **The principal place of business and mailing address is:**  
1017 Buchanan, Hollywood, Florida 33019

**ARTICLE III**           **The objectives and purposes for which the corporation is organized are:**

- A. To operate as a corporation not-for-profit pursuant to Chapter 617, Florida Statutes.
- B. To stimulate people to register to vote.
- C. To assist people in registering to vote.
- D. To mobilize people to vote.
- E. To assist people in voting.
- F. To foster, encourage, and instill a spirit of appreciation of voting and the ideals at the foundation of our republic.
- G. To create an organization to raise contributions and spend funds to achieve these purposes.
- H. To operate on a non-partisan basis.
- I. Generally, to have and exercise all rights and powers conferred on not-for-profit corporations under the laws of the State of Florida, or which may hereafter be conferred on not-for-profit corporations.
- J. Notwithstanding any of the above statements of purposes or powers, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purpose of this corporation.

**ARTICLE IV**

**Directors**

The business and affairs of the Corporation shall be managed by a Board of Directors which shall initially consist of three (3) directors, but which number may be increased from time to time by the Bylaws of the Corporation but which shall never be less than three (3). The Bylaws shall provide for the method of selecting and the method of determining the number of directors.

**ARTICLE VI**

**Officers**

The officers of the Corporation shall consist of a president, vice-president, secretary, treasurer, and other officers as the Board of Directors may from time to time by resolution create. The officers shall serve at the pleasure of the Board of Directors, and the Bylaws may provide for the removal from office of officers, for filling vacancies, and for the duties of the officers.

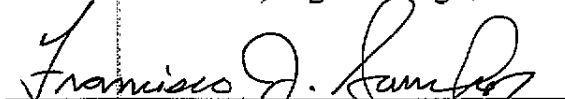
