PLAN OF DISTRIBUTION OF ASSETS OF FRANCISCAN SISTERS OF ALLEGANY RESIDENCE OF WEST PALM BEACH, INC.

This Plan of Distribution of the assets of Franciscan Sisters of Allegany Residence of West Palm Beach, Inc. (the "Corporation") has been prepared and approved in accordance with Florida Statutes, §617.1406(2), consistent with the Corporation's Articles of Incorporation, as amended:

- 1. The Corporation has no liabilities or obligations.
- 2. The Corporation holds no assets upon condition requiring return, transfer or conveyance in the event of dissolution.
- 3. All other assets received and held by the Corporation shall be distributed in accordance with Florida Statutes §617.1406(3)(c)-(d) and the Articles of Incorporation of the Corporation to Franciscan Sisters of Allegany, New York, Inc., or its successors, so long as such distributee is an organization exempt from federal income tax by virtue of being an organization described in Section 501(c)(3) of the Code. Any such assets not disposed of in accordance with the foregoing shall be distributed to one or more corporations, trusts, funds, or organizations which at the time appear in the Official Catholic Directory published annually by P. J. Kenedy & Sons or any successor publication, or are controlled by any such corporation, trust, fund, or organization that so appears, and are exempt from federal income tax as organizations described in Section 501(c)(3) of the Code, as in the sole judgment of the Franciscan Sisters of Allegany, New York, Inc., subject to any approvals described in the Corporation's Articles of Incorporation or Bylaws. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction exclusively to one or more corporations, trusts, funds, or other organizations as said court shall determine, which at the time are exempt from federal income tax as organizations described in Section 501(c)(3) of the Code and which are organized and operated exclusively for such purposes. No private individual shall share in the distribution of any Corporation assets upon dissolution of the Corporation.
- 4. The officers of the Corporation shall file Articles of Dissolution with the Florida Secretary of State pursuant to Florida Statutes, §617.1403 as directed by the Board of Directors of the Corporation.
- 5. The officers of the Corporation shall cause all fees to be paid and to do or cause to be done such other acts as they may deem to be necessary to proper top carry out the dissolution of the Corporation.
