ARTICLES OF INCORPORATION
of
FRIENDSHIP AND PEACE SOCIETY, INC.
A FLORIDA NONPROFIT CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, being natural persons of the age of 21 years or more, for the purpose of forming a not-for-profit corporation under and in accordance with Chapter 617 of the Statutes of the State of Florida, **DO HEREBY CERTIFY:**

ARTICLE ONE: Name

The name of the corporation is **FRIENDSHIP AND PEACE SOCIETY, INC.**

ARTICLE TWO: Duration

The duration of the corporation shall be perpetual.

ARTICLE THREE: Purposes

The purposes for which the corporation is organized:

- A. To educate and invite all people of good will to abandon the memories of historic matters which heretofore have driven apart peoples of different ethnicities, cultures and religions, and to bring them together in friendship and peace for the common good.
- B. The doing of any and all things necessary and incident to the performance of the purposes above set forth insofar as the same are permissible under the statutes of Florida governing this corporation or Section 501 (c), and regulations thereunder, of the Internal Revenue Code, provided that:

- (1) no part of the net earnings of the corporation shall inure to the benefit of or be distributable to its members, directors, officers, incorporators or any other private persons except
- (2) the corporation shall be allowed to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the preceding Article "A" hereof.

ARTICLE FOUR: Members

- A. The corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the corporation. The Bylaws may provide for non-voting members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws. ARTICLE SEVEN: Election of Directors

The method of electing directors and members shall be as provided in the by-laws, except that the number of Directors may be raised or lowered but shall not be fewer than three.

ARTICLE EIGHT: Officers

The officers of the corporation shall consist of a President, Vice President, Secretary and Treasurer. Other officers may be provided for in the Bylaws. One person may hold two

offices. Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time and in such manner as may be prescribed by the Bylaws. The name and address of each initial Officer of the corporation is as follows:

ARTICLE NINE: Non-Stock Basis

The corporation is organized and shall be operated on a non-stock basis within the meaning of Chapter 617, Florida Statutes, and shall not have the power to issue shares of any type or class, but may issue membership certificates if so provided in the Bylaws.

ARTICLE TEN: Dissolution

Upon dissolution of the corporation, liquidation or abandonment of its property, assets remaining after the payment of, or provision for the payment of, all liabilities of the corporation, shall be distributed to one or more not-for-profit organizations whose purposes and activities, in the opinion of the last directors, are consistent with the objectives of public service of this corporation.
