## ADMENDENTS TO ARTICLES OF INCORPORATION OF ACCESS FOUNDATION CORPORATION,

### a Florida not for profit Corporation

The undersigned, acting as the majority of directors and members of the above referenced Florida Corporation under the Florida not for profit Corporation Act, Chapter 617 of the Florida Statutes, hereby adopts the following Amendments to its Articles of Incorporation for such Corporation and the number of votes cast was sufficient for approval.

- 1. It is hereby noted that Article III-Purpose is hereby amended to further state that the organization, Access Foundation Corporation, is organized exclusively for charitable purposes under section 501 (c) (3) of the Internal Revenue Code.
- 2. As and for an additional Article IX, the Corporation hereby adopts the following: No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) of any political campaign on behalf of any candidate for public office.
- 3. As and for an additional Article X, the Corporation adopts the following:

  Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
