

- ONE:** The name and address of this principal corporation is Faith Evangelistic Praise and Worship Center, Inc., 3011 N.W. 183 Street Opalocka, FI 33056. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable and educational purposes. To establish structured support services for homeless and economically disadvantaged individuals, families and juvenil to a life of self-sufficiency. The programs will consist of, but shall not be limited: Childcare, Outreach Advocacy Programs For The Youth At High Risk, Health Care, Homeless, Housing for the Aged, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement, and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS, and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR:** The address of the registered office is Faith Evangelistic Praise and Worship Center, Inc., 3011 N.W. 183 Street Opalocka, FI 33056 and the name and address of the registered agent of the corporation shall be Daisy Jones [Signature] (signature), at 3011 N.W. 183 Street Opalocka FL. 33056. I HEREBY ACCEPT APPOINTMENT AS REGISTERED AGENT AND AGREE TO ACT IN THIS CAPACITY.
- FIVE:**
- (a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (3) of the Internal Revenue Code.

SIX: The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

SEVEN: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Charitable and Educational under Section 501(c)(3) of the Internal Revenue Code.

EIGHT: Executed on November 6 , 2000: The name and address of the three (3) persons appointed to act as the initial Directors and Incorporators of this corporation are eighteen (18) or more years of age: MANNER IN WHICH THE DIRECTORS ARE ELECTED ARE STATED IN THE BYLAWS.
