The undersigned incorporator, for the purpose of forming a corporation  
under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of  
Incorporation:

**ARTICLE I. NAME**

The name of the corporation shall be: **EDGEWOOD YOUTH  
DEVELOPMENT CENTER INC.**, (hereinafter referred to as the "Center").

**ARTICLE II. PURPOSE**

The purpose and object of the Center shall be to teach and spread good  
moral principals based upon methodology in relating to community youth, counseling  
and professional approaches to helping and educating the body, mind, and spirit. The  
Center shall also conduct any and all business consistent with the laws of the State of  
Florida and United States of America.

**ARTICLE III. PRINCIPAL PLACE OF BUSINESS**

The principal place of business of this Ministry shall be 1003 Edgewood  
Avenue, West, Jacksonville, Florida 32208.

#### **ARTICLE IV. TERM OF EXISTANCE**

Commencing on June 26, 2001, the Center shall have perpetual existence.

#### **ARTICLE V. MEMBERSHIP**

Pursuant to the By-Laws, membership in, and services offered by the Ministry are open to all individuals, on a non discriminating basis.

#### **ARTICLE VI. BOARD OF DIRECTORS**

The business affairs of the Center shall be managed by the Board of Directors. The Board of Directors shall be elected by the members of the Center from among the membership at the annual membership meeting as provided in the By-Laws. The number of members of the first Board of Directors shall be five. The names and addresses of the persons who are to serve as the initial Board of Directors of the Center until their successors are chosen are:

### **ARTICLE VIII. BY-LAWS**

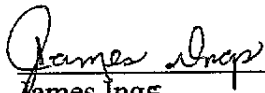
The Board of Directors shall adopt by a majority vote the original By-Laws of the Center.

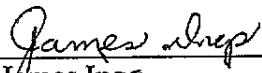
**CERTIFICATE OF DESIGNATION OF
