ARTICLES OF INCORPORATION

Of

PLANTATION SWIM TEAM AT NORTH BROWARD BOOSTER CLUB, INC.

ARTICLE I. NAME

The name of the corporation shall be: Plantation Swim Team at North Broward Booster Club, Inc.

ARTICLE II. PRINCIPAL OFFICE
