DURATION

QUALIFICATIONS FOR MEMBERSHIP

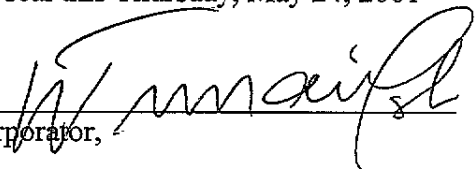

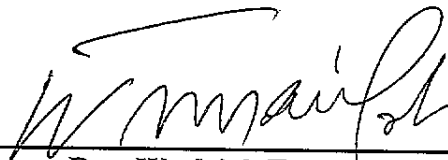
