**ARTICLE I  
NAME**

**ARTICLE III  
PURPOSE**

The purpose for which the corporation is organized is: The business and the objects and purposes proposed to be transacted, promoted and carried on are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, vis:

This is a non-stock, nonprofit corporation. The purpose of the corporation is to engage in any lawful act or activity for which nonprofit corporations may be organized under the General Corporation Law of the State of Florida.

6. To perpetuate all the above to subsequent generations.




