SCOLUL SANS Articles of Incorporation of the undersigned a majority of whom are citizens of the Un States, desiring to form a Not For Profit Corporation under the Florida Not For Profit Corporation Act do hereby certify:

NAME AND INITIAL PRINCIPAL OFFICE

The name of the corporation shall be TURTLE BAY HISTORIC FISH CAMP, INC. The street address and mailing address of the initial principal office of the corporation shall be 1919 Alfred Boulevard, Punta Gorda, FL 33983.

DURATION

TURTLE BAY HISTORIC FISH CAMP, INC. shall have perpetual existence.

PURPOSE

The purposes for which the TURTLE BAY HISTORIC FISH CAMP, INC., is organized are as follows:

TO OPERATE AS A CORPORATION PURSUANT TO THE FLORIDA NOT FOR PROFIT CORPORATION ACT (CHAPTER 617 OF THE FLORIDA STATUTES) AND TO EXERCISE ALL OF THE COMMON LAW AND STATUTORY POWERS OF A CORPORATION NOT FOR PROFIT UNDER THE LAWS OF FLORIDA, WHICH ARE NOT IN CONFLICT WITH THE TERMS OF THESE ARTICLES.

MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the Bylaws.
