

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
INTERNATIONAL STILL'S DISEASE FOUNDATION, INC.
(present name)

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

First: Amendment(s) adopted: ARTICLE III, Amended and added:
Article Number III Amended

The purpose for which the Corporation is organized is: to provide support, offer encouragement, facilitate oral & written communication on Stills Disease to those with the Disease, their Families and Health Care Workers; to increase the general awareness of Stills Disease and to encourage Drug Companies to conduct research on Stills Disease; also to provide Stills Disease Patients, their Families and Health Care Workers with timely notification of bulletins and notices pertaining to new drugs or drug warnings and of new possible side effects. Also to provide possible monetary help to a Stills Patient that the Board decides is warranted.

- A. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from Federal income tax under section 501(c)(3), of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or corresponding section of any future federal tax code.
