

**ARTICLES OF INCORPORATION

- ONE:** The name and address of this principal corporation is Estoria's Adult Day Care Center, Inc., located at 1157 Romaine Circle West, Jacksonville, FL 32225, in Duval County. The principal office is also the mailing address and the address of the registered agent. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.
- TWO:** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Land, Acquisition, Counseling, To provide Adult Day Care, Assisted Living Facilities, Care for disabilities, Homeless Shelter, Community Employment, Seminars, Health Fairs, Aids/HIV Education, Drug Awareness, Rehabilitation of clients back into society, Prison Reform and other programs to aid those in need.
- THREE:** The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR:** The address of the registered office is: 1157 Romaine Circle West, Jacksonville, FL 32225, and the name and address of the registered agent of the corporation shall be: Charlie Mae Jones.



Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organized and operated exclusively for such purposes.
