ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a not for profit corporation pursuant to Chapter 617, Florida Statutes, adopts the following Article of Incorporation.

ARTICLE I

NAME

The name of the corporation shall be Future Leaders of the World Academy, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 717 S.W. Martin Luther King Avenue, Ocala, Florida 34474.

ARTICLE III

COMMENCEMENT OF EXISTENCE

The date of the commencement of corporate existence shall be July 1, 2001.

ARTICLE IV

PURPOSE

The corporation is organized for educational purposes. It will create and operate one or more charter schools pursuant to §228.056, Florida Statutes. The purposes for which the corporation is organized are limited to those that will qualify it as a tax exempt organization under §501(c)(3) of the Internal Revenue Code.

The corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation, except as otherwise provided under §501(h) of the Internal Revenue Code.

No part of the net earnings, properties, or assets of this corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual or director of this corporation. On liquidation or dissolution, property and assets of this corporation shall be distributed and paid over to a tax exempt organization qualified under §501(c)(3) of the Internal Revenue Code.

ARTICLE V

DIRECTORS

The corporation shall have no voting members. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation shall be defined by statute and the by-laws of the corporation. No director shall have any right, title, or interest in or to any property of the corporation.

The Board of Directors for the corporation shall initially have nine directors. The number of directors may be increased or decreased by the by-laws of the corporation.

The Board of Directors shall adopt by-laws for the corporation and the method of election of directors shall be stated in the by-laws.
