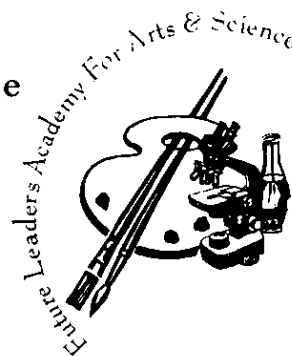

RE: Reinstatement of Future Leaders Academy for Arts and Science

Please be advised by accident I have discovered that the above referenced charter school has been dissolved as a corporation. I immediately called the division of corporation and found that information to be true. Consequently, I requested the necessary documents to apply for reinstatement; I was informed that we (the school) failed to submit the required papers to renew our corporation status with the required fee after the first and second notification deadline.

Unfortunately, we never received any of the notification letters. Further, examination of the problem, I found where the division of corporations sent the notification to 717 SW Martin Luther King Blvd, Ocala. That is not our mailing address. Our mailing address is P. O. Box 4995, Ocala, FL 34472. Also, the school leases one of the buildings from Marion Citrus Mental Agency. That address is the physical location of all of the buildings owned by Marion Citrus Mental Health. We never received any mail with that address. I am terribly sorry for the problem.

NOTE: Marion County School Board has informed the school that they will not release any more funds until the problem is resolved.

Enclosed, please find the required fee and paper work to reinstate our school as soon as possible. Also, due the above summary, I am requesting that the penalty fee be waived.

Thanks for your utmost consideration and cooperation regarding this request. If additional information is needed, please let me know.
