The undersigned Incorporator, in compliance with Chapter 617, F.S. (Not for Profit), hereby executes these Articles of Incorporation in order to form a Corporation Not For Profit under the laws of the State of Florida.

ARTICLE I NAME

The Name of this corporation shall be:
SANCTA FAMILIA ACADEMY, INC.

ARTICLE II INITIAL PRINCIPLE OFFICE

The initial principle place of business and mailing address of this corporation shall be:
1204 N. HARBOR CITY BLVD., MELBOURNE, FL 32935

The Board of Directors may from time to time move the office to any other address in Florida.

ARTICLE III PURPOSE

This corporation, a corporation not for profit, organized under Chapter 617 Florida Statutes, is organized for educational purposes, and specifically those purposes which would qualify it for exemption from Federal Income Taxation under Section 501 (c3) of the Internal Revenue Code. The purposes of this corporation include offering educational activities and assisting parents and teachers with reaching common educational goals, but especially to improve the education afforded children in our community. The corporation will also perform fund raising for all purposes for which the corporation is organized, so long as the same do not adversely affect the corporation's exempt status for income tax purposes, promoting service to the local community, to the State of Florida and the United States. No part of the earnings, if any, of the corporation shall inure to the benefit of any private shareholder, member, or individual, and no substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, except when permitted by the Internal Revenue Code.

ARTICLE IV MANNER OF ELECTION

Officers will be elected by a majority vote of the Board of Directors at the initial meeting of such Board for the offices of President, Vice President, Secretary, and Treasurer. Future elections may be held as set forth in the Bylaws.

ARTICLE V INITIAL DIRECTORS

The corporation shall have three directors initially. The number of Directors may be increased or diminished from time to time, by the By-Laws adopted by the Directors but shall never be less than three.

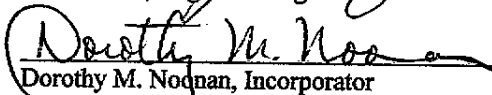
