CERTIFICATE OF INCORPORATION
OF

A FLORIDA NOT-FOR-PROFIT CORPORATION

The undersigned, acting as the incorporator of a not-for-profit corporation under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopts the following Articles of Incorporation for such Corporation:

ARTICLE 1: NAME

The name of the Corporation shall be: EMMANUEL HAITIAN CHRISTAIN COMMUNITY Agency, Inc., hereinafter referred to as the "Corporation".

ARTICLE 2: PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE 3: DURATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE 4: PURPOSES

To advance the general welfare of the community in all fields of human endeavor to promote better understanding between all peoples. To promote and to adhere to genuine democratic principles upholding basic rights such as freedom of expression, freedom of faith, and the inalienable human rights as stated in the constitution and the laws of the United States of America.

ARTICLE 5: REGISTERED OFFICE AND AGENT

ARTICLE 6: ELECTION OF BOARD OF DIRECTORS

The Board of Directors shall be elected by secret ballot. The number of directors may be increased or decreased from time to time by an amendment to the bylaws. All directors shall be selected as provided for in the bylaws.
