### ARTICLES OF INCORPORATION

OF

# GRACE COMMUNITY CHURCH, INC.

In compliance with the requirements of Chapter 617 of the Florida Statutes, the undersigned, all of whom are residents of Florida and all of whom are of full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

## **ARTICLE I**

The name of this corporation is GRACE COMMUNITY CHURCH, INC., hereinafter called the "Corporation."

### **ARTICLE II**

# REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of the Corporation is 6165 E. Irlo Bronson Memorial Highway, St. Cloud, Florida, 34771, and the name of the initial registered agent of this Corporation at that address is ANDY B. AIKENS.

### **ARTICLE III**

# PURPOSE AND POWER OF THE CORPORATION

The purpose of this Corporation shall be the worship of God, the carrying out of the Great Commission given by the Lord Jesus Christ which constitutes evangelism, both at home and abroad, and the development of the spiritual maturing of every believer, and such other purposes as are specified in the Scriptures for a New Testament Church.

This Corporation is organized exclusively for charitable, religious and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the



Internal Revenue Code, or corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, this Corporation shall not disperse any of its receipts, nor carry on any activities not permitted by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the internal Revenue Code, or corresponding section of any future federal tax code.

### ARTICLE IV

# SCRIPTURAL FOUNDATION FOR THE CORPORATION

The Corporation recognizes the Scriptures, both the Old and New Testaments as set out in the original manuscripts, as the verbally inspired Word of God, authoritative, inerrant, infallible, and God-breathed (II Timothy 3:16-17; II Peter 1:20-21; Matthew 5:18).

## **ARTICLE V**

## NON-PAYMENT OF SALARIES

No part of the Corporation's income shall be distributed to its directors or officers and the Corporation shall not have or issue shares of stock or pay dividends. Nothing herein shall be construed to preclude the Pastor, Associate Pastor, Music Pastor, and clerical staff from serving the Corporation and/or from receiving reasonable compensation from services actually rendered to the Corporation in effecting one or more of its purposes.

### ARTICLE VI

### **MEMBERSHIP**

The membership of this Corporation shall be composed of persons who have given evidence of regeneration by the Spirit of God, who have been baptized by immersion, who have subscribed to the Church Covenant, Articles of Faith, and Constitution of the Corporation, and have completed the New

Member's Class, and who have been received into membership by vote of the Church Body.

# **ARTICLE VII**

# INITIAL OFFICERS AND DIRECTORS

The initial officers and trustees shall serve until the first annual general meeting of the members of the Corporation after incorporation.

# ARTICLE VIII

### INDEMNIFICATION

Every director and every officer of the Corporation shall be indemnified by the Corporation against all expenses and liabilities, including counsel fees, reasonably incurred by or imposed upon him/her in connection with any proceeding or any settlement of any proceeding to which he/she may be a party of in which he/she may become involved by reason of his/her being or having been a director or officer at the time such expenses are incurred, except when the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his/her duties; provided, that in the event of a settlement, the indemnification shall apply only when the Board of Directors (Trustees) approves such settlement and reimbursement as being for the best interest of the Corporation. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such director or officer may be entitled.

## ARTICLE IX

### DISSOLUTION

If for any reason this Corporation is dissolved, after the payment of all liabilities against the Corporation, all assets shall be distributed to such organization or organizations selected by the Corporation that are organized and operated exclusively for charitable, educational, or religious purposes as shall qualify as an exempt corporation or organization under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, (or by the corresponding section of any future Revenue Code of the United States of America), or to a corporation or organization to which contributions are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954, as amended (or the corresponding section of any future United States Revenue Law). Any such assets not so disposed of

shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

No part of the property, buildings, monies, or assets of this Corporation shall ever inure to the benefit of any donor, member, officer of this Corporation, or any individual.

## ARTICLE X

### DURATION

The Corporation shall exist perpetually.

### ARTICLE XI

#### **AMENDMENT**

These Articles may be amended or repealed and new Articles adopted at any regular or called meeting of the assemble by a two-thirds majority vote of the members present, provided that the proposed action has been submitted in writing and announced at least two (2) weeks prior to said meeting.

## ARTICLE XII

### **BYLAWS**

The bylaws of this Corporation shall be adopted by the members and may be altered, amended, or rescinded in the manner provided by the bylaws.




