

**ARTICLES OF INCORPORATION

- ONE: The name and address of this principle corporation is New Yoruba Foundation, Inc., 2658 Fletcher Court, Hollywood, FL 33020. The corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.
- TWO: This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law, and shall be operated exclusively for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The program shall consist of, but shall not be limited to: Economic Development, Community Enrichment, Social Reconstruction, Affordable Housing, Rights of Passage, Cultural Diversity, Vocational Training, Transitional Housing, Land Acquisitions, Thrift Store, Food Bank, Youth Offenders, Substance Abuse, Career Development, Youth at High Risk, Education, Tutoring, Literacy, and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR: The address of the Registered Office is 2658 Fletcher Court, Hollywood, FL 33020, Broward County, and the name of the registered agent of the corporation shall be:

- FIVE:
- (a) The corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 © (3) of the Internal Revenue Code.
 - (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.



SEVEN: The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution of winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for Charitable and Educational purposes under Section 501 © (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a state or local government for public purposes. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


