ARTICLE I: NAME

The name of the corporation shall be TAMPA AIDS MEMORIAL PARK FOUNDATION, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be P. O. Box 18885, Tampa FL 33679-18885.

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is to raise funds to build and maintain the City of Tampa's AIDS Memorial Park so that those infected and/or affected by the AIDS pandemic can be remembered and honored.

ARTICLE IV: MANNER OF ELECTION

Nominations for elected officers are accepted from the general membership, followed by election via the simple majority process. Elected officers serve for a period of five (5) years; should an officer fail to complete the term an election will be held to determine the replacement. Method of election of directors is as stated in the bylaws.


