In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: *to provide alcohol & drug free transitional and PERMANENT SUPPORTED housing and on site case management services to the homeless substance abuse, HIV and dually diagnosed populations of Broward County. TO ESTABLISH LONGTERM SAFE AND SUPPORTIVE ENVIRONMENTS THAT SHELTER AND FOSTER achieving self-sufficiency AND INDEPENDENCE THROUGH IMPROVED LIFE MANAGEMENT SKILLS. TO REDUCE ALLEVIATE SUBSTANCE ABUSE AND SPREAD OF AIDS AND HOMELESSNESS IN BROWARD COUNTY.*

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

DIRECTORS SHALL BE ELECTED BY THE GENERAL MEMBERSHIP AT THE ANNUAL MEETING AND WILL IMMEDIATELY BEGIN THEIR TERM. TERM OFFICE SHALL BE 2 YEARS, WITH APPROXIMATELY ONE THIRD OF THE DIRECTORS TO BE ELECTED EACH YEAR.
