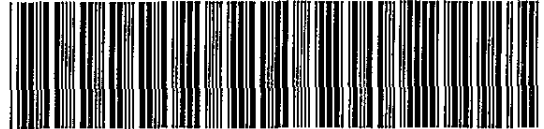



AMENDMENTS ADOPTED: FIVE (5)

1- SAID (CORPORATION/ASSOCIATION/TRUST) IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, EDUCATIONAL, RELIGIOUS OR SCIENTIFIC PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 (OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE)

2- NO PART OF THE NET EARNINGS OF THE (CORPORATION/ ASSOCIATION/TRUST) SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO, ITS MEMBERS, TRUSTEES, DIRECTORS, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE (CORPORATION/ ASSOCIATION/TRUST) SHALL BE AUTHORIZEDD AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF SECTION 501(C)(3) PURPOSES.

3- NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE (CORPORATION/ASSOCIATION/ TRUST) SHALL BE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE (CORPORATION/ASSOCIATION/TRUST) SHALL NOT PARTICIPATE IN OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF, OR IN OPPOSITION TO, ANY CANDIDATE FOR PUBLIC OFFICE.

4- NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE (CORPORATION /ASSOCIATION/TRUST) SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON BY A (CORPORATION/ASSOCIATION/TRUST), EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 (OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE).

5-UPON DISSOLUTION OF THIS (CORPORATION/ASSOCIATION/TRUST), ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE (OR CORRESPONDING SECTIONN OF ANY FUTURE FEDERAL TAX CODE) OR SHALL BE DISTRIBUTED TO THE FEDERAL, STATE OR LOCAL GOVERNMENT FOR A PUBLIC PURPOSE

**BYLAWS  
OF  
RIVER OF GOD MINISTRY INTERNATIONAL, INCORPORATION  
(AMENDED)**

**ARTICLE I**

**NAME AND OFFICE**

Section 1. The name of this organization shall be River of God Ministry International, Inc.

Section 2. The principal office of River of God Ministry International shall be located at 107 Oak Hill Ridge Road, Valrico, FL 33594.

**ARTICLE II**

**FISCAL YEAR**

The Book and Record will be kept on a calendar year basis.

**ARTICLE III**

**BOARD OF DIRECTORS**

Section 1. The Board of Directors shall initially be appointed for two (2) years and thereafter their successors will be appointed a two (2) year term.

1.2 Upon nomination by the Board, Board members may serve for 2 additional consecutive 2-year terms.

Section 2. The Board of Directors will consist of a President, Vice President, Treasurer, and Secretary. Any one person can hold no more than two offices at a time. The Board of Directors shall appoint the officers.

2.1. The Board of Directors shall be composed of no few than 3, no more than 10 members.

2.2 President: The President shall be the primary elected officer. S/he shall preside at all Board of Directors meetings and be responsible for the oversight of all Board duties.

2.3 Vice President – can only act in the absence of President.

2.4 Secretary: The secretary shall ensure that accurate meeting minutes are kept and maintained, financial records are maintained and reports are made at each Board meeting.

2.5 Treasurer – be an authorize signature on all assets. Oversee the recording of all financial transactions.

Section 3. The Board of Directors will direct the management of River of God Ministry International to the Director.

#### Section 4. QUORUM

A duly constituted quorum of the Board of Directors shall be two-thirds (2/3) of all duly elected members of the Board.

#### Section 6. MANNER OF ACTING

6.1 A simple majority of those members present at a regularly constituted meeting of the Board of Directors shall constitute an act of the Board provided there is a quorum.

6.2. The Board of Directors may also act by simple majority of all members through a mail ballot.

### **ARTICLE IV**

#### **MEETINGS**

Section 1. The Board of Directors meets once a quarter at such locations as previously designated by them. The Board may meet more often depending upon available resources and needs.

Section 2. The Board of Directors is authorized to remove someone who failed to attend two consecutive meetings.

#### **AMENDMENTS**

These By-Laws may be amended from time to time by the action of the Board of Directors and brought to the total body for confirmation.
