The Articles of Incorporation of Medical Resources, Inc.

Articles on Incorporation of the undersigned, whom are citizens of the United States, desiring form a Nonprofit Corporation under the Non-Profit Corporation Law of Chapter 617, Florida Statutes, do hereby certify:

Article One: The name of the Corporation shall be Medical Resources, Inc.

Article Two: The principal place of business and mailing address of the Corporation is to be located at 4718 Dutton Drive Orlando, Florida 32808

Article Three: The corporation is organized exclusively for charitable, educational job preparedness of soft skills and certification. Medical Resources Inc. will be the transitional processes by which unemployed and employed persons can enhance their future longevity in the workforce of today. The making of distributions to organizations that qualify as exempt organizations under 501© (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
