(A NOT FOR PROFIT CORPORATION)

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby form a corporation under the Florida Not for Profit Corporation Act, and adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of this Florida Not for Profit Corporation shall be, United Futbol Corporation.

ARTICLE II DURATION

This corporation shall exist perpetually unless dissolved according to Florida Law, and as stipulated in Article IX of this document.

ARTICLE III PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office shall be, 9753 S. Orange Blossom Trail Suite. 201 Orlando Florida, 32837.

ARTICLE IV PURPOSE

To organize, implement, and maintain a youth soccer program.

To educate and develop youth soccer players at all levels of play, recreational and competitive.

To provide an equal opportunity for all youth wishing to play the game of soccer regardless of race, creed, color, national or ethnic origin, or religion.

To have the right to own, hold in trust, use, sell, convey, mortgage, lease, or otherwise dispose of such property, real or chattel, as may be needed for the prosecution of its work.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

Manner of electing directors shall be as provided in the By-Laws of this corporation. The initial board of directors shall consist of four members. Board of director members may be increased or decreased in number as provided for in the By-Laws, but may not be less than three board members. 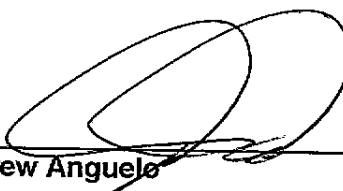
ARTICLE IX DISSOLUTION

The assets of United Futbol Corporation, a Florida Not for Profit Corporation, are irrevocably dedicated to charitable purposes. In the event of liquidation, dissolution, or the revocation of its charter or abandonment of its stated purpose, after providing for payment of debts and obligations of the corporation, the remaining assets will not inure to the benefit of any private person or persons but all such remaining assets will be distributed to a nonprofit organization, or to nonprofit organizations, which are organized and operate exclusively for religious and/or charitable purposes which are exempt under Section 501c(3) of the Internal Revenue Code, under which section the organization or organizations shall have established tax exempt status.

Article X AMENDMENTS

These Articles of Incorporation may be amended as provided for by law. Amendments shall be approved by the Board of Directors (trustees).
