The UNDERSIGNED, natural persons of legal age acting as incorporators of a not-for-profit corporation under Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation for such applicable corporation.

ARTICLE I-NAME

The name of the Corporation is HOWARD A. ROBERTS MINISTRIES, INC

ARTICLE II-DURATION

The term for which this church shall have existence shall be perpetual.

ARTICLE III-NATURE OF BUSINESS

Said corporation is organized exclusively for religious purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c)(3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue Law); to conduct community revitalization initiatives, youth and family enrichment programs, community economic development programs and to engage in any lawful business allowed for nonprofit corporations under the laws of the State of Florida.

ARTICLE IV-MANNER OF ELECTION OF DIRECTORS

The methods of selection of the Directors shall be provided in the by-laws of the corporation.

ARTICLE V-REGULATION OF INTERNAL AFFAIRS

The Internal affairs of the corporation are governed by the "BY-LAWS" which shall be established and approved by the majority of the directors at the first meeting of the board of directors.

ARTICLE VI-LIMITATION CORPORATE POWERS

The corporate power of this corporation is provided in section 617.0302, Florida Statutes. There are no provisions limiting the powers of the corporation except as prohibited by section 617.0833

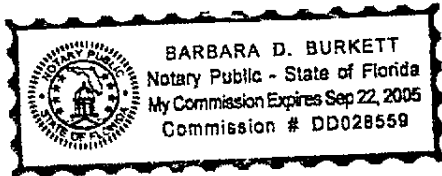
