Notice is hereby given that the undersigned incorporators, all of full age, have associated themselves together for the purpose of forming a corporation not for profit, without capital stock, under the provision of chapters 607 and 617, Florida Statutes and we do hereby make, subscribe, acknowledge, and file theses Articles of incorporation.

**ARTICLE I NAME**

The name of the incorporation shall be: CHRISTIAN ACTIVITIES' ORGANIZATION OF CENTRAL FLORIDA, INC.

**ARTICLE II CORPORATION PURPOSE**

The object and purpose of the corporation shall be to raise, receive and maintain a fund or funds of real property of personal property, or both, and to distribute administer the fund or funds, including any income or interest generated there from, exclusively for charitable, religious or educational purposes.

The purpose shall include, but not limited to, the congregation, religious worship, education, organization, and support of the membership and community.

**ARTICLE X –GENERAL**

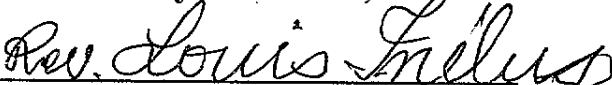

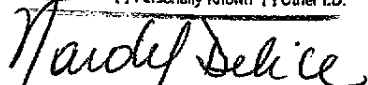
