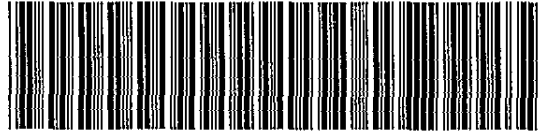



### **ARTICLE III**

THE CORPORATION IS ORGANIZED FOR THE PURPOSE OF PROMOTING COMMUNITY AND SELF-DEVELOPMENT THROUGH CULTURAL AND PHILOSOPHICAL EXCHANGES, HEALTH EDUCATION, PUBLIC SAFETY EDUCATION, AND TRADITIONAL ASIAN MARTIAL TRAINING. THE CORPORATION WILL BE OPERATED "NOT FOR PROFIT". MEMBERSHIP IS OPEN TO ANY PERSON, CORPORATION OR BUSINESS MAKING A YEARLY PAYMENT TO PROVIDE SUPPORT FOR THIS ORGANIZATION. NOT WITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THIS CORPORATION SHALL NOT, EXCEPT TO AND IN SUBSTANTIAL DEGREE, ENGAGE IN ANY ACTIVITIES OR EXERCISE, OR EXERCISE ANY POWERS THAT ARE NOT IN FURTHERANCE OF THE PURPOSES OF THIS NOT FOR PROFIT CORPORATION.

SAID CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL AND SCIENTIFIC PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS UNDER SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE (OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE).

NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES, DIRECTORS, OFFICERS OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE

### **ARTICLE X**

UPON THE DISSOLUTION OF THIS CORPORATION ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501 (c) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE.
