1. The name and address of this principle corporation is Hand-Up Community Development, Inc. 8627 Samona Dr. W. Jacksonville, Fl. 32208 in Duval County. The corporation is an organized pursuant to the State of Florida Non-profit Corporation Code.
2. This corporation is a non-profit Public Benefit Corporation and is organized to aid mankind through Economic and Community Development Programs. The corporation is organized under the Non-profit Public Benefit Corporation Laws. The programs will consist of Economic and Community Development Programs, but shall not be limited to: Homelessness, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Job Placement, Employment, and other support to aid those in need.

- (b) This corporation is organized and operated exclusively for the Public Benefit purposes within the meaning of Section 501 (c) 3 of the Internal Revenue Code.

(c) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) 2 of the Internal Revenue Code.

6. The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed are to act as the initial Directors of this Corporation:

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for Public Benefit or Religious, under Section 501 (c) 3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the County in which the principle office for the such purposes.
