The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

**ARTICLE I: Name**

The name of the corporation shall be New Covenant Firstborn Outreach Ministries, Inc.

**ARTICLE II: Principal Office**

The principal place of business of the corporation shall be 2901 Northwest 46<sup>th</sup> Avenue, Apartment 308, Lauderdale Lakes, Florida 33313.

**ARTICLE III: Purpose**

The purpose for which the corporation is organized is to create a united body of members whose purpose is to glorify God, faithfully disciple all who come to relationship with Jesus, reaching the needy and distressed with the life-giving message of Jesus Christ. The corporation is intended to be a religious not-for-profit organization and will seek tax exempt status from the Internal Revenue Service. The period of this corporation is perpetual unless dissolved according to law.
