Articles of Incorporation
of
VINEYARDS ELEMENTARY PTA, INC.
A Florida Nonprofit Corporation

We, the undersigned natural persons of legal age, acting as incorporators of a corporation under Chapter 617 of the Florida Statutes, hereby adopt the following articles of incorporation:

Article I

The name of the corporation is VINEYARDS ELEMENTARY PTA, INC. (hereinafter the "association")

Article II

The association is a nonprofit corporation.

Article III

The period of its duration is perpetual.

Article IV

The association is formed for the following primary purposes:

Section 1: The purposes of the association, in common with the Objects of the National PTA are:

- a. To promote the welfare of children and youth in home, school, community and place of worship;
- b. To raise the standards of home life;
- c. To secure adequate laws for the care and protection of children and youth;
- d. To bring into closer relation the home and the school, that parents and teachers may cooperate intelligently in the education of children and youth; and,

- e. To develop between educators and the general public such united efforts as will secure for all children and youth the highest advantages in physical, mental, social and spiritual education.

Section 2: The Objects of this association are prompted, in cooperation with the state PTA and the National PTA, through an educational program directed toward parents, teachers, and the general public; are developed through conferences, committees, projects, and programs.

Section 3: The organization is organized exclusively for the charitable, scientific, literary, or educational purposes within meaning of section 501(c)(3) of the Internal Revenue Code or corresponding Section of any future Federal tax code (hereinafter "Internal Revenue Code").

Article V

The street address of the initial registered office of the association is 6225 Arbor Boulevard West, Naples, Florida 34119, and the name of its initial registered agent at that address is ROBERT SPANO.

Article VI

The Principal Office of the association is 6225 Arbor Boulevard West, Naples, Florida 34119.

Article VII


