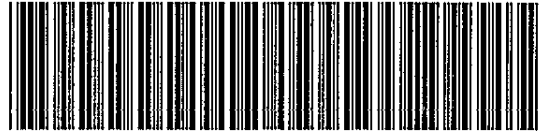



**HOUSE OF PRAISE MINISTRIES CHURCH, INC.**  
**59-3732072**

Add to Article II:

5. This organization is organized exclusively for religious & charitable purposes within the meaning of the section 501(c)(3) of the Internal Revenue Code.

Change to Article IX:

DISTRIBUTION OF ASSESTS UPON DISSOLUTION

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or shall be distributed to the Federal government, or to a state or local government for public purpose. Any such assets not so disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the association is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
