## CERTIFICATE OF FIRST AMENDMENT TO THE ARTICLES OF INCORPORATION FOR LAKE SHEEN RESERVE HOMEOWNERS ASSOCIATION, INC.

THIS IS TO CERTIFY that the following constitutes the First Amendment to the Articles of Incorporation of Lake Sheen Reserve Homeowners Association, Inc., which, pursuant to Article XV of the Articles of Incorporation, was approved by two-thirds (2/3rds) of each class of Members of the Association:
