ARTICLES OF INCORPORATION OF GLOBAL HUMANITARIAN AID, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned of full age of majority, have for the purpose of forming a non-profit corporation pursuant to the laws of the State of Florida, for the purposes expressed in ARTICLE III hereof, adopted the following Articles of Incorporation:

ARTICLE I - NAME

The NAME of this corporation shall be GLOBAL HUMANITARIAN AID, INC, and its duration is to be perpetual.

ARTICLE II - PRINCIPAL OFFICE

The NAME of the registered agent and the location and principal address of the corporation's registered office in the State of Florida is Leon van Rooyen. The principal address is 5620 East Fowler Ave., #8 Tampa FL 33617

ARTICLE III - PURPOSES

This nonprofit corporation is organized and operated exclusively for humanitarian aid, within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, of the United States of America.

In furtherance of its nonprofit, tax-exempt purposes, the corporation shall have the following powers and authority; however, the corporation shall not be empowered, and is prohibited from, engaging in any activity which is not allowed pursuant to Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, of the United States of America:

- 1. Provide worldwide humanitarian aid, relief, education, and development;
- 2. Utilize modern technology to use every possible vehicle or means to empower and develop indigenous nations, body, soul and spirit;
- 3. Effectively distribute food and clothing to people and countries in need of aid and assistance because of, but not limited to, natural, political or other disasters;
- 4. Develop long term administrations in third world nations to maintain the humanitarian cause;
- 5. Teach, educate, train, sustain and equip local leaders so as to maintain development of their physical, emotional, social and spiritual needs;

6. Uphold and support the value of every human soul regardless of age, sex, race, color, religion, mental status, national origin, ancestry or economic condition.

No part of the net earnings of the Corporation shall inure to the benefit of any individual.

Notwithstanding any provisions of these Articles of Incorporation, the corporation shall <u>not</u> engage in any political activity proscribed by Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, of the United States of America, nor shall any income or assets of the corporation inure to the benefit of any member, private individual or business entity.

ARTICLE IV DIRECTORS

The number of Directors, and their qualifications, of this corporation shall be established in the bylaws of this corporation. The Board of Directors and Elected Officers shall be the only voting members of the corporation and shall conduct all of the business of the corporation except as specifically delegated.

ARTICLE V - NO CAPITAL STOCK

This non-profit corporation is formed without any purpose of monetary profit to itself or its members and shall have no capital stock.

ARTICLE VIII - DISSOLUTION

Upon dissolution of the corporation for any cause, all of the assets and property, both real and personal, then owned or controlled by this corporation shall revert to and become the property of an non-profit institution accorded tax-exempt status under Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, of the United States of America, to be designated by the board of Directors; provided, however, that the just debts and liabilities of the corporation shall first be paid. Upon dissolution, none of the assets or property of the corporation shall devolve to the benefit of any private individual or business entity of the corporation.

ARTICLE IX - CEO

The CEO of the Corporation shall manage the daily affairs of the corporation. The President will be elected on an annual basis from the voting members of the corporation.

ARTICLE X - BY-LAWS

The by-laws of the corporation may be made, altered, or rescinded by the Board of Directors of the corporation, through regular or special meeting.

ARTICLE XI – AMENDMENTS

These Articles may be amended at any regular meeting of the membership of the cooperation, or at a special meeting called for that purpose, by a two-thirds (2/3) majority.
