FOR
END-TIME APOSTOLIC TABERNACLE OF PRAYER

The undersigned acting as incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

ARTICLE III: PURPOSE

The specific purpose for which this corporation is organized is (are):

To establish a church, work, and ministry with a plan of salvation as it relates to the Bible, God's holy, inspired word. One must repent, confess, forsake, acknowledge their sins, and agree in accordance to the death of Christ, burial of Christ, and resurrection of our Lord & Saviour Jesus Christ.

To establish a church, a work, and a ministry that will reap this last day harvest and usher in the coming of Christ through radio, streets, television, revivals, and crusades both at home and abroad.

To establish a church, a work, and a ministry that will strive for the unity of the faith believing that there is one Lord, one faith, and one baptism (Eph.4:5), and that there is neither Jew nor Greek, there is neither bond nor free, there is neither male nor female, but ye are all one in Christ Jesus, (Galations 3:28) upon receiving the new birth experience. (I Corins 5:17) (St. John 3:3)

To establish a church, a work and a ministry whose mission will have a burden for soul-winning and that is reaching out to the world, in fulfillment of the Great Commission to "Go ye unto all the world, and preach the gospel to every creature." (St. Mark 16:15b) (St. Matthew 24:14) and this gospel be preached in fullness without compromise under the inspiration of the Holy Ghost (2 Tim. 3:16, 17)

To establish a church or a work that will serve as an Outreach Center for people of all race, creed, and color; a place that will lift up, magnify, and glorify the Lord Jesus Christ, the son of the living God.

To establish a church, a work, or a ministry "For the perfecting of the saints, for the work of the ministry, for them edifying of the body of Christ." (Ephesians 4:12) and to raise up born again believers that are sanctified wholly, baptized and filled with and walking in the manifestation of the fruit and gifts of the Holy Ghost; conforming to the very image of Jesus Christ, and fulfilling the purpose of God.

ARTICLE IV: MEMBERSHIP

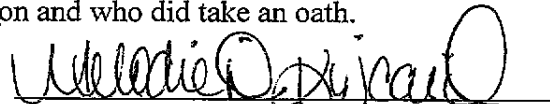

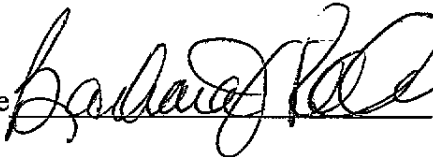
