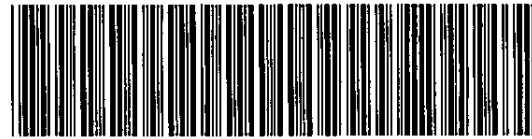

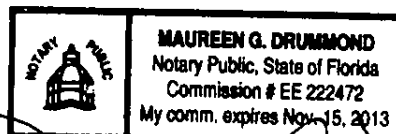
**Board of Directors Minutes of Meeting**

Board of Directors Meeting for the year of 2013-2014 was held on the week of May 15, 2013 via conference call to verify new members of Ruth House Ministries International, Inc. All members currently on the Board agreed to become active members and are all In favor of the responsibilities associated with it. Members not in favor were deleted for This year with a nay vote. An amendment to the minutes were held again to appoint a Secretary to the board – Debbie Guterriz, a Treasurer – Cassandra Robinson, and a Vice-President to assist the Pastor and President Barbara Robinson as Vice President to the board - Naomi Sanders. All members of the board will serve in the capacity of Chaplain, to be apt to stand in the gap in prayer before and after all future meetings. Active and current board members are listed as Directors and members or future members of the five-fold ministry as it relates to Ephesians 4:11 for the perfecting of the saints and for the edifying of the body of Christ. They are listed as Apostle Annie Darville, Dr. Myrtle Newbold, Prophetess & Pastor Wanda Fullwood-Holmes, Co-pastor Sandra Leggett-Richardson, Renuld Robinson, Clifton Sanders, Pastor Betty Jamison, and Pastor Mary Coston and Anthony Sanders. Robinson so that more responsibilities will be given to the effectiveness of the ministry.
