Articles of Incorporation

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

Article I: Name

The name of the corporation shall be:

Trinity Baptist Church of Palm Bay, Inc.

Article II: Principal Office

The principal place of business and mailing address of this corporation shall be:

2803 Palm Bay rd., N.E. Palm Bay, Florida. 32905

Article III: Purpose

The specific purpose(s) for which the corporation is organized shall be the advancement of the Kingdom of God. It shall promote this through public worship of God and the preaching of the Gospel, through consistent Christian living, personal evangelism, missionary endeavors, and Christian education. The Church shall also recognize the total implications of the Gospel of Jesus Christ in ministering to the spiritual, economic, social and physical needs of individuals.

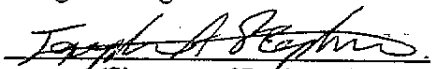
