Articles of Incorporation

ARTICLE 1: Corporate Name

The name of the corporation shall be **Garden Villa's Neighborhood Family Center, Inc.**
Hereinafter referred to as GVNFC.

ARTICLE 2: Principle Office

The Garden Villas Neighborhood Family Center shall have its principal office(s) at 60 A Sandlewood Drive West, Clearwater, Pinellas County, Florida.

ARTICLE 3: Purpose

The GVNFC is to encourage parents and residents to take an active role in the healthy development of children by creating opportunities to strengthen and support families in an environment that promotes, respects, and embraces the cultural and ethnic diversity of all whom enter.

ARTICLE 4: Manner of Election of Directors
