ARTICLE I NAME

THE NAME OF THIS CORPORATION SHALL BE **KNOWLEDGE MINISTRIES INC.**

ARTICLE II PRINCIPAL OFFICE

THE PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS OF THIS CORPORATION SHALL BE:
1989 WINNERS CIRCLE
CANTONMENT, FL. 32533-5727

ARTICLE III PURPOSE

THE PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED IS:

1. TO HELP ESTABLISH AMONG THE IMPOVERISHED, PRODUCTIVE AND LIFE-CHANGING RELATIONSHIPS WITH JESUS CHRIST BY PROCLAIMING THE SALVATION MESSAGE THROUGH COMPASSIONATE MERCY MINISTRIES.
2. TO TEACH YOUTH TO COPE WITH STRESS AND PRESSURE BY HAVING ANGER MANAGEMENT CLASSES.
3. TO HELP YOUTH TO BE BETTER PREPARED FOR THE FUTURE BY HELPING THEM WITH MILITARY TEST AND COLLEGE TEST.
4. TO PROMOTE CHRISTIAN GROWTH AS CHARACTERIZED BY A PRODUCTIVE, CHANGED LIFE.
5. TO RAISE THE RESOURCES OF VOLUNTEER HELP, PRAYER SUPPORT, MONEY, IN KIND GIFTS AND LONG-TERM CHURCH FOLLOW-UP FROM CHURCHES AND COMMUNITY.

LET IT BE KNOWN THAT:

1. THE CORPORATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS AND EDUCATIONAL PURPOSES SET FORTH IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE.
2. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL BE INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS DIRECTORS, MINISTERS OFFICERS OR OTHER PRIVATE PERSONS EXCEPT THAT THE CORPORATION SHALL BE EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSES SET FORTH IN THESE ARTICLES OF INCORPORATION.
3. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION AND A CORPORATION SHALL NOT PARTICIPATE IN OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE.
4. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER 501(C)(3) OF THE INTERNAL REVENUE CODE, (B) BY A CORPORATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE, UNDER SECTION 170(C)(2) OF THE INTERNAL REVENUE CODE, OR (C) BY A NONPROFIT CORPORATION ORGANIZED UNDER THE LAW OF THE STATE OF FLORIDA.

ARTICLE IV MANNER OF ELECTION

THE CORPORATION SHALL BE ORGANIZED ON A NON-STOCK BASIS AND SHALL HAVE NO MEMBERS. THE AUTHORITY FOR ALL AFFAIRS IN THE CORPORATION SHALL BE IN A BOARD OF DIRECTORS WHO SHALL HAVE AND MAY EXERCISE ALL OF THE POWERS OF THE CORPORATION AS PERMITTED BY FEDERAL LAW, STATE LAW, THESE ARTICLES OF INCORPORATION AND THE BY-LAWS OF THE CORPORATION AS FROM TIME TO TIME IN EFFECT. THE BOARD OF DIRECTORS SHALL BE COMPOSED OF NOT LESS THAN TWO(2) PERSONS NOR MORE THAN TEN(10) PERSONS, ALL OF WHOM SHALL BE CHRISTIANS. THE INITIAL BOARD SHALL CONSIST OF TWO(2) PERSONS.
