**ARTICLE I  
NAME**

The name of the corporation is **CHRIST ACADEMY, INC.**

**ARTICLE II  
PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

**ARTICLE III  
PURPOSES**

Christ Academy, Inc. is a not for profit corporation. The specific purpose for which this corporation is formed is to operate is to operate a school and by doing so, to support families in preparing their children to reach their maximum academic potential while equipping them to love the Lord, walk in His ways, and obey His commands according to scripture. The general purpose for which the corporation is formed is to operate exclusively for purposes which will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE IV  
LIMITATION OF CORPORATE POWERS**

The Corporate powers of this corporation are as provided in §617.0302 of the Florida Statutes. The corporation shall not exercise any of its powers for pecuniary profit and shall not perform any function prohibited to corporations not-for-profit by the laws of the State of Florida.

No part of the net earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code.)

#### **ARTICLE V**

#### **ELECTION OF BOARD OF DIRECTORS**

The manner in which the directors of this corporation are elected or appointed shall be as stated in the bylaws of the corporation.

#### **ARTICLE VI**

#### **REGISTERED OFFICE AND AGENT**

The street address of the initial registered office of this corporation is 1919 Atlantic Boulevard, Jacksonville, Florida 32207 and the name of the initial registered agent of this corporation at that address is Arthur G. Sartorius, III.

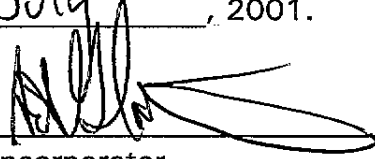
